This filter is built with a robust galvanized frame and uses glass fiber paper media for efficient filtration. Bag filters are commonly used in heating, ventilation and air-conditioning (HVAC) systems, and serve as final filters in many applications, including industrial, commercial and healthcare. The service life of bag filters can vary according to user preferences, the type of installation and the geographical location of the installation site.

MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A1: covers the extraction and processing of raw materials, as well as the production of materials and components used in the manufacture of bag filters: filter media, galvanized frames, mastics, hot-melt adhesives and wires.

A2: includes transportation of the materials and components to the production site Kežmarok, Slovakia.

A3: covers production of the bag filters at the production site in Kežmarok. This stage includes electricity consumption for bag assembly and filter assembly, as well as the electricity consumption for general processes, such as heating and lighting. Bag assembly includes trimming and stitching the rolled media into a pocket shape including thread and hot melt.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

A4: covers the transport of bag filters from the storage site (Deltrian BE) to the end customer. The average distance is estimated at 778 km (Truck: average 259 km and Boat: average 519 km). Customers in Canada have not been taken into account, as they represent less than 1% of the average distance. The year represented is 2022.

A5: we only use a cardboard box for the packaging of this product. This module covers the transport of cardboard to waste management: some is incinerated, some goes to the recycling center and the rest is recycled.

PRODUCT USE AND MAINTENANCE (B1-B7)

B1: includes the accumulation of dirt in the filter and consequent reduction of airborne particles.

B6: Includes electricity consumption during one year of bag filter operation. Electricity consumption has been calculated in accordance with Eurovent 21/04/2019. Air, soil, and water impacts during the use phase have not been studied

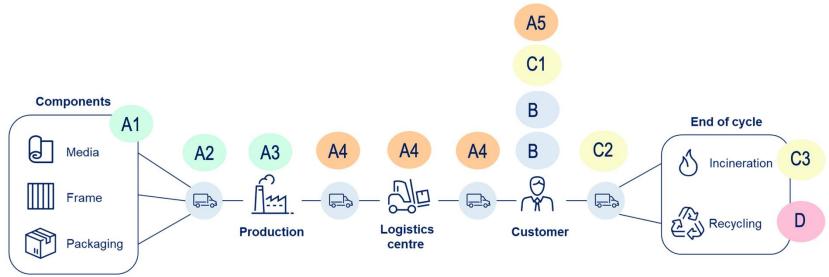
PRODUCT END OF LIFE (C1-C4, D)

- **C1**: this pertains to the manual removal process of the filter from the equipment.
- C2: this encompasses the journey from the user's site to the waste treatment facility. The average distance travelled is estimated to be 80 km.
- **C3**: covers incineration of the filter and collected dust. The incineration process is carried out with energy recovery.
- C4: deals with the deposition of filter ash
- **D**: covers the energy recovery potential of the incineration process.

Life-cycle assessment.

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

All raw materials used in production have been included in the model calculations. The processes and transport involved in recycling the material back to the production site are taken into account.

Life-Cycle Stages Excluded:

- The study does not take into account the impact of the production and maintenance of the infrastructure and equipment used to manufacture the products (since it was assumed to have a minor share per product). However, it does include the electricity used by this equipment.
- Business travel and travel to and from work of personnel.
- In the manufacturing stage (A3), the burdens associated with the incineration of media waste have been excluded. However, the media waste itself is included.
- In use (B1), only the carbon content of the collected dust was taken into account when estimating the total calorific value of the dust.
- In module C4, the landfilling of ash from filter incineration was excluded as it generates negligible environmental impact, assuming high process efficiency.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:
